## 5. Footpaths

## 6. Cemetery and New Cemetery

The Clerk also reported that she had contacted LWH in Pwllheli for advice on the developments for the new cemetery; they had said that they may be able to assist and had suggested a meeting to discuss the matter.

### 7. Playing Field

It was reported that Rhys Joens had been unable to erect the fence, as the ground was rock and that he had advised that a different contractor would be required to complete the work.

A report from Alwa Ceris, Chair of Playing Field Committee, had been received, requesting Llanbedrog Community Council's feedback on signage. As the report had been received shortly before the council meeting, it had not been possible to include it with the meeting papers.

- Chair to discuss using Playing Field AONB grant funds for the fence and signage as needed.

Ian Williams reported back from the latest committee meeting. A price had been received for a one-off deep clean of the Village Hall - £150 + VAT.
